The following must be adhered to in order to participate in the WVWS All Member Exhibit 2017:

Watercolors or water-based media on paper, YUPO, or watercolor board are eligible. There is no age limit on the pieces but they must have not been shown in any previous WVWS exhibit. This is a members only exhibit. Work is not juried therefore, all paintings will be hung, if framing and content is deemed acceptable. Members may submit 2 paintings.

- All work must be framed properly (no poster frames) and under plexi-glass—**no regular or glazed glass**...no exceptions. Wire hangers only. No saw-tooth hangers. The chair and Gallery 11 reserves the right to not hang a painting if rules are not followed or if content is deemed unacceptable or inappropriate. Gallery phone number is: 304-342-0083. Check out their website at: www.galleryeleven.com Shipped work is to be mailed in time for it to be received by November 25 to: Linda Elmer, 46 Dogwood Lane Fairmont, WV 26554. Phone number: 304-216-8498. Paid, return labels must be provided or work will not be returned.
- All work must be original. No stock photos or internet images are allowed (not an original source). Purchased stock photos as a source are not permitted. No work may be submitted that was done during a workshop or heavily influenced by another artist.
- **Sales**—Gallery 11 retains 30%. The WVWS will retain 3% so price your work accordingly.
- **Drop off/Pick up**—Work can be delivered between November 27-30 and must be picked up by January 5 or by arrangement the week after through Gallery 11. Shipped work will be sent out after the 5th.
- **Awards**—Entry fees--along with a limited amount from the treasury--will determine the size of the awards. Over \$1,500 in award money will be given.
- Those who want to have their work displayed on the website can e-mail their image to Kristen Colebank, webmaster, or Linda Elmer. The exhibit will be judged for awards, but not juried for entry.
- **Art Bin/Card Rack/Insurance**--Artists in the exhibit can submit up to 3 extra works for the art bin (see additional page for those qualifications). The **Insurance form** must also be filled out and returned with registration form.

Entry Form for the Art Bin & Card Rack (return with your entry form)

WVWS is adding another opportunity to its annual exhibits. Whenever allowed, accepted artists may provide additional unframed artwork, reproductions or cards to be sold on the art exhibit premises. The idea is to provide unframed pieces that may be more affordable in price or more options by the artist.

Criteria: The artist may submit 3 items. These items must be properly packaged in a sealable display pouch or shrink wrapped. Mark your work with your name, title, media, price (reflecting the 30% commission and 3% for the WVWS), and size. If the work is a reproduction i.e. print, it must also be stated on your tag. Criteria for selection should be as stated in the above prospectus in terms of originality. Reproductions do not have to be like the framed exhibition artwork. Matting is highly recommended.
