

## **WVWS Jury for Status Requirements – 2019**

### **Calendar:**

**June 15** – last day to request application by mail. Application will be available on WVWS website until July 1.

**July 1** – images and forms postmarked to Laurie Goldstein-Warren for preparation for the jury committee

**No later than September 30** – Member is notified of results; president, membership chair, web master and newsletter editor are contacted.

### **General Guidelines:**

1. Paintings must be created by using a water-based media in an aqueous manner on paper or board.
2. Artwork may have been exhibited in WVWS exhibits.
3. Work created in a workshop or classroom or with direction from any instructor is not allowed.
4. All pieces submitted to the jury committee must be the artist's own original creation.
5. Paintings created from photo images must be of the artist's original sources (photos taken by and property of the entering artist). Sources must not be from copyrighted materials including internet sources or appropriated/copied from other art.
6. In mixed media pieces, water media must be dominant.

### **General Digital Specifications:**

1. Submit images in jpeg format on a CD. Use the finest setting your camera will allow. File names on the disk should match the painting titles. Provide an image list with your name, size of image, title and number. Digital images should be an accurate depiction, and not enhanced.
2. Try opening your images on a different computer to make sure that the CD will open.
3. All image areas should be devoid of dead space, frames or mats. Cropping digital image to the edge of the painting is the

best presentation. Label each file by the title of the painting or an abbreviated version of the title. Include dimensions.

(Example: Landscape\_22x30)

4. Your submitted CD will be retained for archiving purposes.

### **Juried Status Applicants:**

1. Submit 6 digital images of work completed since January 1, 2015.
2. Fill out application form and review sheet for committee comments.
3. Provide a self-addressed stamped envelope to receive results.

### **Signature Status Applicants:**

1. Only Juried status members may apply for Signature status.
2. Submit 4 digital images of work that have NOT been submitted to a juried WVWS exhibit.
3. Submit documentation/proof of acceptance into at least two WVWS juried exhibits within a period of 6 years. (Copies of catalogs, newsletter articles, printouts from the WVWS website, etc. showing your name will serve this purpose.)
4. Fill out application form and review sheet for committee comments.
5. Provide a self-addressed stamped envelope to receive results.
