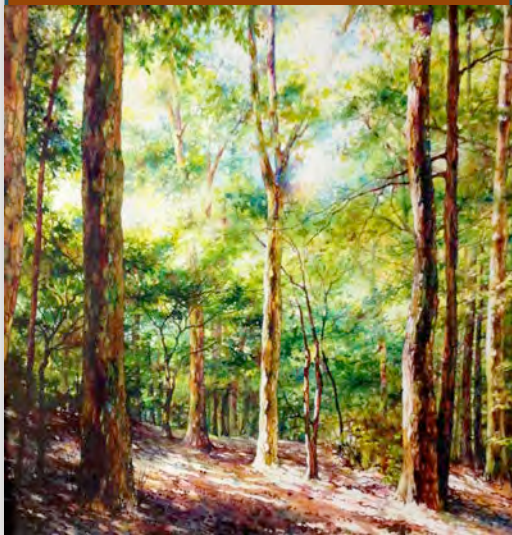

The following must be adhered to in order to participate in the WVWS All-Member Exhibit 2019:

Watercolors or water-based media on paper, YUPO, or watercolor board are eligible. There is no age limit on the pieces but they must have not been shown in any previous WVWS exhibits. This is a members-only exhibit. Work is not juried; therefore, all paintings will be hung if framing and content is deemed acceptable. Members may submit 2 paintings.

All work must be framed properly (no poster frames) and under plexi-glass—**no regular or glazed glass**...no exceptions. Wire hangers only. No saw-tooth hangers. The chair and **ArtSpring Gallery** reserves the right to not hang a painting if rules are not followed or if content is deemed unacceptable or inappropriate. Shipped work is to be mailed in time for it to be received by November 1 to: Linda Elmer, 46 Dogwood Lane, Fairmont, WV 26554. Phone number: 304-216-8498 or 304-366-9793. Paid return shipping labels must be provided or work will not be returned. Contact person at gallery is Nanette Seligman **304-481-6230**. All work must be original. No stock photos or Internet images are allowed (not an original source). Purchased stock photos as a source are not permitted. No work may be submitted that was done during a workshop or heavily influenced by another artist. There is no time limit (as to when **the paintings** have been created) on these pieces. No work should have been shown in a previous WVWS exhibit.

Sales—The gallery retains 40%. The WVWS will retain 3% , so price your work accordingly.

Drop off/Pick up---Work can be delivered by dates listed in the calendar and must picked up by January 8 or by arrangement the week after through the gallery. Shipped work will be sent out about January 10.

Awards—Entry fees--along with a limited amount from the treasury--will determine the size of the awards. Approximately \$1,200 in award money will be given.

Those who want to have their work displayed on the website can e-mail their image to Kristen Colebank, webmaster, or Linda Elmer. The exhibit will be judged for awards, but not juried for entry.

Art Bin & Christmas Ornaments—Artists in the exhibit can submit up to 3 handmade ornaments for the special Christmas tree ornament sale OR 3 unframed pieces for the art bin. These are additional sale items for the artist. (see additional page for those qualifications). These must be sent in with your pre-registration page. You need to pre-register so an inventory list can be created.

Criteria: The artist may submit 3 items. These items must be properly tagged with your name and price. Watercolors need to be marked as originals or reproductions. Pieces should be matted and packaged. (Price should also reflect the 40% gallery commission and 3% for the WVWS).
