

WVWS Jury for Status Requirements – 2021

Calendar:

July 13, 2021 – images and forms received by Debbie Lester for preparation for the jury committee (*if sending application by mail, send early to ensure receipt by this deadline*).

Approximately Sept. 1, 2021 – Member is notified of results; president, membership chair, webmaster and newsletter editor are notified of results.

General Guidelines:

1. Paintings must be created by using a water-based media in an aqueous manner on paper or board.
2. Work created in a workshop or classroom or with direction from any instructor is not allowed.
3. All pieces submitted to the jury committee must be the artist's own original creation.
4. Paintings created from photo images must be of the artist's original sources (photos taken by and property of the entering artist). Sources must not be from copyrighted materials including internet sources or appropriated/copied from other art.
5. In mixed media pieces, water media must be dominant.

General Digital Specifications:

1. Submit images in jpg format by email to Debbie Lester at deborahdlester@gmail.com.
2. Digital images should be no larger than 3 MB each. If they are larger, they may not be able to go through as an email attachment. You should also send each image as a separate attachment (one image per email) to improve the likelihood the emails will go through.
3. File names of digital images should be formatted as **PaintingTitle_heightXwidth** (*example SunnyDay_15x22*).
4. Complete and email (or mail) the Application Form and the appropriate image list (whether for Juried or Signature Status). Be sure the image file names match the names on the image list before you begin sending emails. If you cannot send images by email, you may mail Debbie a CD of images, along with the paper forms.
5. Digital images should be an accurate depiction and not enhanced.
6. All image areas should be devoid of dead space, frames or mats. Cropping digital image to the edge of the painting is the best presentation.

Juried Status Applicants:

1. Submit 6 digital images of work completed since Jan. 1, 2017. The six images may have been exhibited in a previous WVWS exhibit.
2. Fill out the application form and image list for the committee.
3. Provide a self-addressed stamped envelope to receive results.

Signature Status Applicants:

1. Only Juried status members may apply for Signature status.
2. Submit 4 digital images of work that have NOT been accepted into a juried WVWS exhibit.
3. Submit documentation/proof of acceptance into at least two WVWS juried exhibits within a period of 6 years. (Refer to copies of catalogs, newsletter articles, printouts/screenshots from the WVWS website, etc. showing your name and show information/date. You can also refer to the WVWS website at <http://www.watercolorssociety.org/wvws-juried-exhibition-exhibitors/>)
4. Fill out application form and image list sheet for the committee.
