WVWS Bylaw Updates

At the October 30, 2010, Annual meeting the two (2) proposed Bylaw updates were approved.

Paragraph 2.1 will have the additional sentence at the end: Instead of renewing annually, a member may elect to pay lifetime dues of \$300.

Paragraph 2.2 will now read: If a member's renewal dues are not paid by December 31st, a \$10 penalty will be added to the dues. This penalty will not apply to new members joining after December 31 or to members renewing at the life rate.


